Nearly one thousand students from across New Jersey attended the statewide 2018 New Jersey Clean Communities Kids-Teen Award Day and 15th Annual Conference, at the South County Park, hosted by Hunterdon County's Health Division, on May 23-25<sup>th</sup>.
